#### **Moderator**

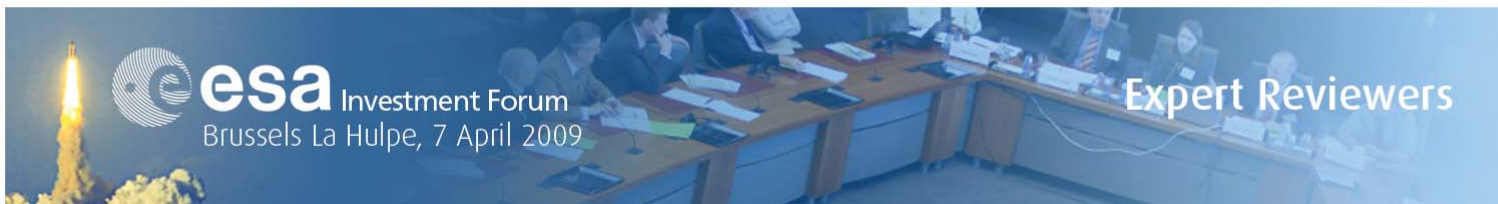
Ensures smooth and lively running of the session by:

- Preside over Q&A after presentations
- Wrap-up session and ensure experts return feedback form to him.

#### **Expert Reviewers**

The expert reviewers are to help the moderator make the session lively and highly interactive by:

- Providing Feedback on Company & Researcher presentations, particularly on:
  - Strengths & weaknesses and/or investment opportunities
  - Suggestions to strengthen/improve the business or investment opportunity
- Asking short questions to the presenters
- We advise expert reviewers to keep their direct comments short and build on other experts' input
- Filling out the feedback form provided on site and rating the presentations
